

REPORT OF THE GENESEE COUNTY INDUSTRIAL DEVELOPMENT AGENCY'S PUBLIC HEARING OF PLUG POWER INC., HELD ON THURSDAY, JUNE 3, 2021, 10:00 A.M. AT THE ALABAMA TOWN HALL, 2218 JUDGE ROAD, OAKFIELD, NEW YORK, AND ELECTRONICALLY VIA VIDEO CONFERENCE

II. CALL TO ORDER

The public hearing of Plug Power Inc. Project was opened at 10:00 am electronically via video conference and in person at the Alabama Town Hall.

III. PROJECT SUMMARY

Plug Power has agreed to advance funds of up to \$55.3M to undertake the engineering, procurement, and construction (EPC) of the STAMP main campus substation given its significant interdependency with the success of their Project Gateway, which relates to the development and construction of a Green Hydrogen production facility on the STAMP campus.

Subsequent to the public hearing held on March 22, 2021, Plug Power submitted a modified application requesting (i) an increase to the amount of financial assistance being contemplated by the Agency for the benefit of the Company, and (ii) to modify and supplement the definition of the Project to include the acquisition, construction and equipping of an approximately 345kV to 115kV main substation (the "Substation") in support of the planning, design, construction and operation of a green hydrogen production and distribution facility to be located at 6840 Crosby Road in the town of Alabama, New York.

IV. COMMENTS

M. Masse began the public hearing by introducing himself as the Sr. VP of Operations of the Genesee County Economic Development Center. He then stated the purpose and guidelines for the public hearing. The purpose of the public hearing is to solicit comments and feedback from the public regarding the proposed additional incentives, which includes an increase in the Sales Tax Exemption on the above outlined project by \$2,800,000. There were no written comments received ahead of time to be included with the written record.

Cole Reuben submitted written comments via the Zoom "Chat" feature. He wrote: "The Tonawanda Seneca Nation is very concerned about possible impacts of the Plug Power facility on its lands, environment, people and culture. These impacts have not been explained or considered. The Nation urges GCEDC and the Town of Alabama to analyze all the possible impacts of the project before authorizing any financial assistance or approving Plug Power's application".

In response to Cole Reuben's statement, M. Masse confirmed that the GCEDC has been in discussions with tribal leadership for the last 5-6 years regarding potential projects at STAMP. The GCEDC continues to work on analyzing any potential impacts that Plug Power, or any other potential projects, may pose to the Nation.

M. Masse concluded by asking for any additional or final comments. Those comments that were made during the public hearing will be presented to the Board tonight.

V. ADJOURNMENT

The public hearing was closed at 10:12 am.

Subsequent to the public hearing held by the Agency on March 22, 2021, the Company submitted a modified Application to the Agency requesting that the Agency (i) increase the amount of Financial Assistance being contemplated by the Agency for the benefit of the Company, and (ii) modify and supplement the definition of Project to include the acquisition, construction and equipping of an approximately 345kV to 115kV main substation (the "Substation") in support of the planning, design, construction and operation of a green hydrogen production and distribution facility to located at 6840 Crosby Road in the Town of Alabama, New York.

The Agency contemplates that it will provide financial assistance to the Company to acquire, construct and equip the Substation in the form of a sales and use tax exemption for purchases and rentals related to the acquisition, construction, and equipping of the Substation.
