The proposed project involves the development on approximately 130-acres within the Genesee County Science, Technology, and Advanced Manufacturing Park (STAMP) in the Town of Alabama, Genesee County, New York. The proposed project will include 90 acres of permanent development; 60 acres on the North Campus and 30 acres on the South Campus. These areas include an approximately 2.2 million-square-foot data center campus, housing three (3), two-story buildings. An additional 40 acres will be utilized as temporary construction logistics areas in support of the project. The proposed location of the site is along the west side of Crosby Road, starting directly southwest, 600 linear feet south of the Lewiston Road (Highway 77)/Crosby Road intersection.

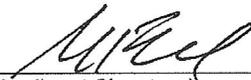

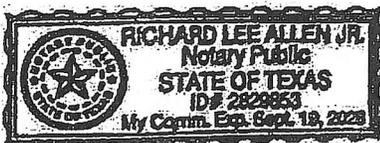

## EXHIBIT A

### INSURANCE COVERAGE

1. Requirements. The Company shall maintain or cause to be maintained insurance against such risks and for such amounts as are customarily insured against by businesses of like size and type paying, as the same become due and payable, all premiums in respect thereto, including, but not necessarily limited to:

(a) (i) Insurance against loss or damage by fire, lightning and other casualties, with a uniform standard extended coverage endorsement, such insurance to be in an amount not less than the full replacement value of the Project, exclusive of excavations and foundations, as determined by a recognized appraiser or insurer selected by the Company or (ii) as an alternative to the above requirements (including the requirement of periodic appraisal), the Company may insure the Project under a blanket insurance policy or policies covering not only the Project but other properties as well.

(b) Workers' compensation insurance, disability benefits insurance, and each other form of insurance which the Agency or the Company is required by law to provide, covering loss resulting from injury, sickness, disability or death of employees of the Company who are located at or assigned to the Project.

(c) Insurance against loss or losses from liabilities imposed by law or assumed in any written contract and arising from personal injury and death or damage to the property of others caused by any accident or occurrence, with limits of not less than **\$1,000,000** per accident or occurrence on account of personal injury, including death resulting there from, and **\$1,000,000** per accident or occurrence on account of damage to the property of others, excluding liability imposed upon the Company by any applicable workers' compensation law; and a blanket excess liability policy in the amount not less than **\$3,000,000** per accident or occurrence, protecting the Company against any loss or liability or damage for personal injury or property damage.

2. Additional Provisions Respecting Insurance. (a) **All insurance required shall name the Agency as a named insured and all other insurance required by Section 4 hereof shall name the Agency as an additional insured.** All insurance shall be procured and maintained in financially sound and generally recognized responsible insurance companies selected by the Company and authorized to write such insurance in the State. Such insurance may be written with deductible amounts comparable to those on similar policies carried by other companies engaged in businesses similar in size, character and other respects to those in which the Company is engaged. All policies evidencing such insurance shall provide for (i) payment of the losses of the Company and the Agency as their respective interest may appear, and (ii) at least thirty (30) days' prior written notice of the cancellation thereof to the Company and the Agency.

(b) All such policies of insurance, or a certificate or certificates of the insurers that such insurance is in force and effect, shall be deposited with the Agency on the date hereof. Prior to expiration of any such policy, the Company shall furnish the Agency evidence that the policy has been renewed or replaced or is no longer required by this Agent Agreement.

### ATTACHMENT TO APPLICATION FOR FINANCIAL ASSISTANCE

#### Local Labor Workforce Certification

(Effective – August 4, 2022)

Project applicants (the “Company”), with projected / committed capital investment for facility construction of greater than or equal to \$5,000,000 (except solar projects as defined later), as a condition to receiving Financial Assistance (including a sales tax exemption, mortgage recording tax exemption, real property tax abatement, and/or bond proceeds) from the Genesee County Industrial Development Agency d/b/a Genesee County Economic Development Center (the “Agency”), will be required to utilize qualified Local Labor, as defined below, for all projects involving the construction, expansion, equipping, demolition and/or remediation of new, existing, expanded or renovated facilities (collectively, the “Project Site”). Solar projects in excess of 5 MW (AC) will be subject to the Local Construction Labor Policy as well.

#### Local Labor Defined

Local Labor is defined as individuals residing in the following Counties: Genesee, Orleans, Monroe, Wyoming, Livingston, Wayne, Ontario, Seneca, Yates, Niagara, Erie, Chautauqua, Cattaraugus and Allegany (collectively, the “Local Labor Area”).

#### Local Labor Requirement

At least 90% of the total number of Project employees, excluding construction project management, of the general contractor, subcontractor, or subcontractor to a subcontractor (collectively, the “Workers”) working on the Project Site must reside within the Local Labor Area. Companies do not have to be local companies as defined herein, but must employ local Workers residing within the Local Labor Area to qualify under the 90% local labor criteria.

It is understood that at certain times, Workers residing within the Local Labor Area may not be available with respect to a Project. Under this condition, the Company is required to contact the Agency to request a waiver of the Local Labor Requirement (the “Local Labor Waiver Request”) based on the following circumstances: (i) warranty issues related to installation of specialized equipment or materials whereby the manufacturer requires installation by only approved installers; (ii) specialized construction for which qualified Local Labor Area Workers are not available; (iii) documented lack of Workers meeting the Local Labor Area requirement; or (iv) cost differentials in bids whereby use of local labor significantly increases the construction cost of the project. Prior to the granting of said waiver, the lowest bidding contractor which bid said construction project using local labor would have the right of first refusal to bid and match the lowest bid as a remedy to ensure compliance with this policy. Comprehensive documentation and justification will be required including documented evidence and verification by GCEDC staff or agents that the “right of first refusal” remedy has been effected unsuccessfully.

The Company will be responsible for the costs of an outside consultant who will perform the inspections, monitoring, and waiver processing for the duration of the construction of the project. The GCEDC will require the Company to provide a deposit to be kept in escrow by the Agency. Any unused funds at the end of construction will be returned to the Company.

The Agency shall evaluate the Local Labor Waiver Request and make its determination related thereto based upon the supporting documentation received with such waiver request.

#### Local Labor Reporting Requirement

Companies authorized to receive Financial Assistance from the Agency will be required to file or cause to be filed a Local Labor Utilization Report (the “Report”) on such form as made available by the Agency, and as directed by the Agency, which will identify, for each Worker, the city, town, or village and associated zip code that each such Worker is domiciled in. The Report shall be submitted to the Agency or its designated agents as follows: (i) immediately prior to commencement of construction

activities; and (ii) on or by the next following quarterly dates of January 1, April 1, July 1, and October 1 and each quarterly date thereafter through the construction completion date.

The Agency, or its designated agents, shall have the right, during normal business hours, to examine and copy the applicable books and records of the Company and to perform spot checks of all Workers at the Project site to verify compliance with the Local Labor Requirement throughout the construction period.

Enforcement

If Agency staff determines that: (i) the Local Labor Requirement is not being met; or (ii) upon use of its reasonable discretion, discovers or becomes aware of a compliance issue related to the Local Labor Requirement, then written notice delivered by Certified Mail of said Local Labor Requirement violation (the "Notice of Violation") shall be provided to the Company.

The Company shall have 10 business days thereafter to either:

- (i) provide written confirmation to the Agency indicating that it has cured the violation and is now in compliance with the Local Labor Requirement;
- (ii) submit the Local Labor Waiver Request as described above; or
- (iii) confirm in writing its inability to meet the Local Labor Requirement.

If the Company does not respond to the Agency's Notice of Violation, or if the Company confirms its inability to meet the Local Labor Requirement, then the Agency shall immediately terminate any and all Financial Assistance being provided to the Project in accordance with the terms of the underlying agreements between the Agency and the Company with respect to the Project. If a Local Labor Waiver Request is submitted and the Agency declines to issue the requester waiver, then the Company shall have 10 business days after receipt of the notice of the waiver request denial to provide written confirmation to the Agency indicating that it has cured the violation and is now in compliance with the Local Labor Requirement. 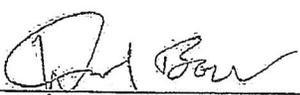

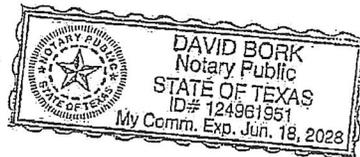

Project Description

Project Double Reed encompasses approximately 90 acres of permanent development; 60 acres on the North Campus and 30 acres on the South Campus. The project includes the construction of (i) three data halls totaling up to 900,000 square feet of data hall space, two on the North Campus and one on the South Campus (the "Data Halls") with total building area of 2,200,000 square feet, with (ii) the supporting utility, access and site improvements for the Data Halls (the "Improvements"), including the installation of hardware, software, furnishings, machinery, equipment and related infrastructure in the Data Halls (the "Equipment"), all for data processing and computer services. An additional 40 acres will be utilized as temporary logistics areas in support of the project.

Project Entities

Stream will create three entities, each of which will enter into lease/leaseback relationships with the GCEDC, Eagle BUFA1, LLC for the South Campus and Eagle BUFA2, LLC and Eagle BUFA3, LLC for the North Campus. Each project entity will be initially owned by the applicant with ownership modified as equity investors become participants in the development of the project. If change in control of project entities occurs pursuant to the infusion of investor funding, GCEDC consent will not be unreasonably conditioned, withheld or delayed or subject to additional fees other than reasonable attorney's fees.

Property

#### Project Investment

The South Campus will be developed on a 30-acre parcel of land to be acquired by the Eagle BUFA1, LLC from Plug Power Holdings LLC (“Plug”). The North Campus will be developed on a 60-acre parcel to be acquired by Eagle BUFA2, LLC and Eagle BUFA 3, LLC , pursuant to a Purchase and Sale agreement presented to GCEDC. The Applicant may, for financing purposes, create a condominium for the North Campus dividing it into two parcels for the development of the data halls as well as a common area element. The Applicant has also proposed to obtain from GCEDC, two construction period easements on property to be utilized as staging and laydown areas on the 30 acre north of the Edwards parcel on the east side of Crosby Road and the 10 acre parcel north of the Plug Power site each owned by GCEDC.

#### Power Availability

The initial projected investments of Eagle BUFA1, LLC in the South Campus and Eagle BUFA2, LLC and Eagle BUFA 3, LLC in the North Campus are set forth on Exhibit A attached hereto as is the projected investment of the tenant in each Data Hall. The total projected investment is currently estimated to be up to \$19.461 Billion.

The Applicant has entered into an agreement with Plug Power for the transfer by Plug to GCEDC all of Plug’s right title and interest into those elements of the STAMP substation acquired and funded by Plug. Pursuant to the Purchase and Sale Agreement with GCEDC, the Applicant has agreed to reimburse GCEDC, up to Fifty Million Dollars for the additional costs necessary for GCEDC to complete the construction and commissioning of the STAMP Substation. Upon completion of the STAMP Substation, GCEDC will transfer its ownership of the high voltage portion of STAMP Substation to the New York Power Authority and the low voltage side to National Grid. In consideration for the

payment to GCEDC and the transfer by Plug of its rights to the STAMP Substation, GCEDC will covenant to reserve for the combined use of the Applicant's two project entities, 500MW of the available 600MW of capacity approved for the STAMP Substation.

## Tax Exemptions

The acquisitions of the Plug parcel and the GCEDC parcel are conditioned upon the Board of Directors of the GCEDC providing, following completion of the necessary regulatory processes including SEQRA, the following (collectively, the "Financial Assistance"):

(a) Mortgage Recording Tax. An exemption from mortgage recording tax sized to cover the investment of Applicant in the Data Halls and Improvements. Based on current cost estimation of project costs, the total combined mortgage recording tax exemption would be up to \$25 Million (excluding the additional tax for the Rochester-Genesee Regional Transportation District).

(b) Sales and Use Taxes ("Sales Tax"). An exemption from Sales Tax sized to cover the combined investment of Applicant and the tenant in the Project. Based on current cost projections the total combined Sales Tax exemption would be up to \$1.37 Billion covering the initial construction and capital investment of both the Applicant and the tenant. It is currently projected that approximately \$457 Million in exemption will be utilized on the South Campus and \$913 Million on the North Campus.

(c) Real Property Tax and PILOT. The Applicant is requesting an all-inclusive fiscal burden including the PILOT with GCEDC and host community agreement with the impacted taxing jurisdictions that has an annual cap on the total of: (i) any property taxes, (ii) special district taxes, and (iii) host community and/or education contribution payments. The Applicant is seeking a cap of \$7 Million covering all Data Halls, land and improvements, (the "Annual Cap") for a term

of 30 operating years. The Applicant is requesting that one- third of the Annual Cap be attributable to each data hall building, with payments starting in the year that a data hall receives its certificate of occupancy. The Annual Cap will increase with a 2% annual escalator which escalation shall start three years after the initial certificate of occupancy. The all encompassing PILOT/tax/host community agreements will also cover the construction period, but no payments will be owed during the construction period or prior to the first payment other than the taxes paid on the parcels of land at the current FMV except with regard to the South Campus. The Applicant proposes to assume the obligations of Plug under the existing Tax Agreement with GCEDC and the Host and Education Contribution Agreements with the impacted taxing jurisdictions until the receipt of the certificate of occupancy for the proposed construction on the South Campus. Following the receipt of the certificate of occupancy, the PILOT/HCA plan set forth above will become operative. The first payment will be due for the tax jurisdiction fiscal years associated with the first taxable status date occurring after completion of construction.

Agency Fees

The Applicant is requesting a waiver from the local labor policy of the GCEDC, permitting forty percent of the labor utilized on the project to be outside of the labor policy for the construction of the Data Hall on the South Campus. The waiver request form is being filed simultaneously with the filing of this application. The applicant reserves the right to apply for waivers for the construction of the Data Halls on the North Campus in an amount to be determined.

The Applicant is proposing that the GCEDC fees be paid with Applicant paying (i) a fee to GCEDC of Three Quarters of One Percent of

the capital cost of the Project payable (i) with \$2,500,000 paid at the initial closing with GCEDC, (ii) 40% of the fee due for the investment in each Data Hall due within 60 days of the issuance of the certificates of occupancy per Data Hall and the remaining 60% of the project fee payable for each Data Hall in equal annual installments over a twenty year period thereafter (iii) the balance of the fee paid on a schedule to be determined based upon a plan to be negotiated with the GCEDC (iv) the fee for services of Harris Beach of \$500,000, and (iv) the fees of Philips Lytle incurred during the SEQRA process and associated litigation occurring thereafter..
